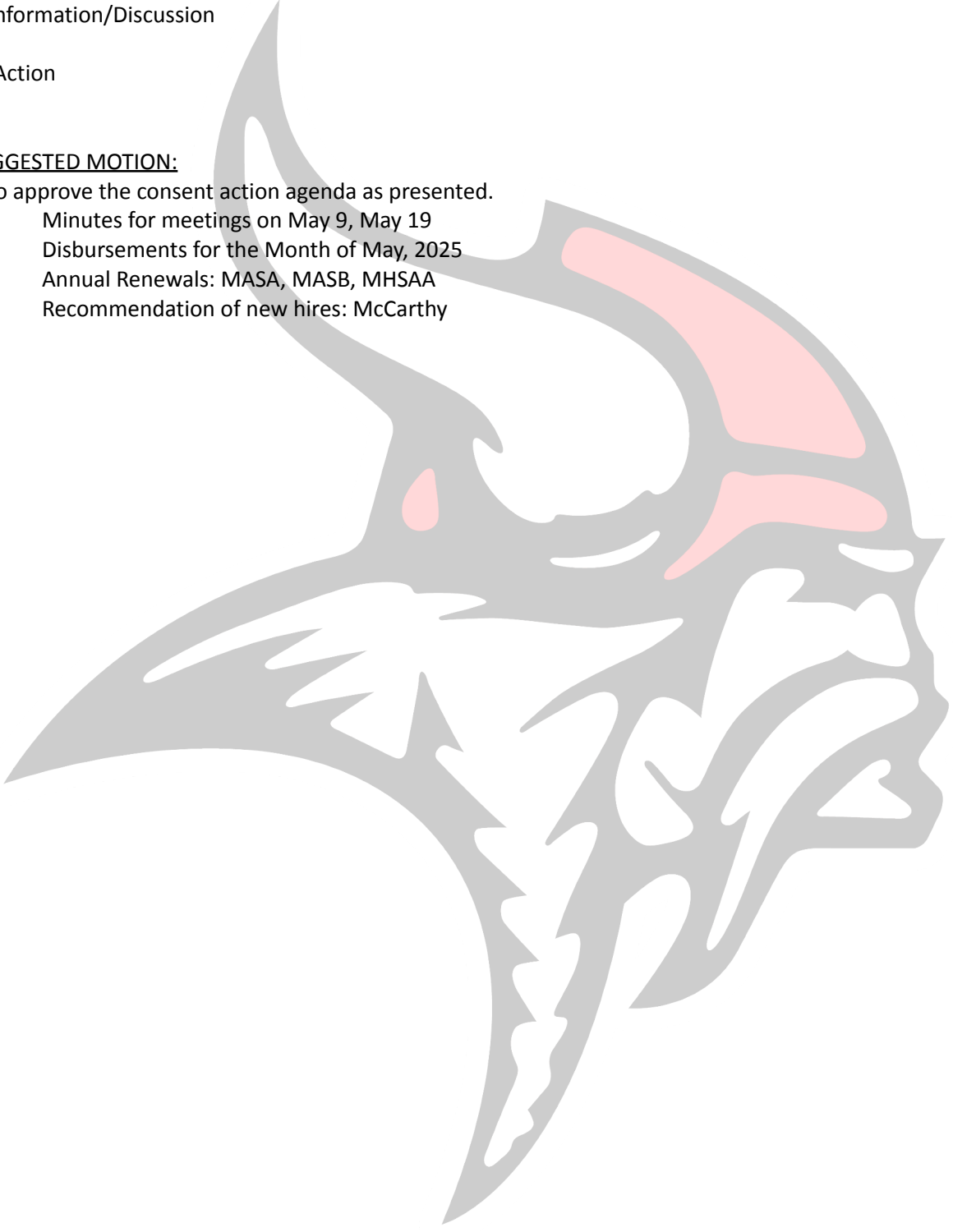

BACKGROUND

Whitehall District Schools Board of Education is required to adopt a budget so that appropriations may be made for school district operations. This represents the initial budget for the 2025-26 fiscal year for all the funds – General Fund, WLACE Fund, Food Service Fund, and the Technology & Security Fund. State law also requires a budget hearing to be held each year, and this meeting fulfills this requirement and also provides the opportunity to discuss the budget process. The required budget hearing and opportunity for public comment was held as a prior agenda item.

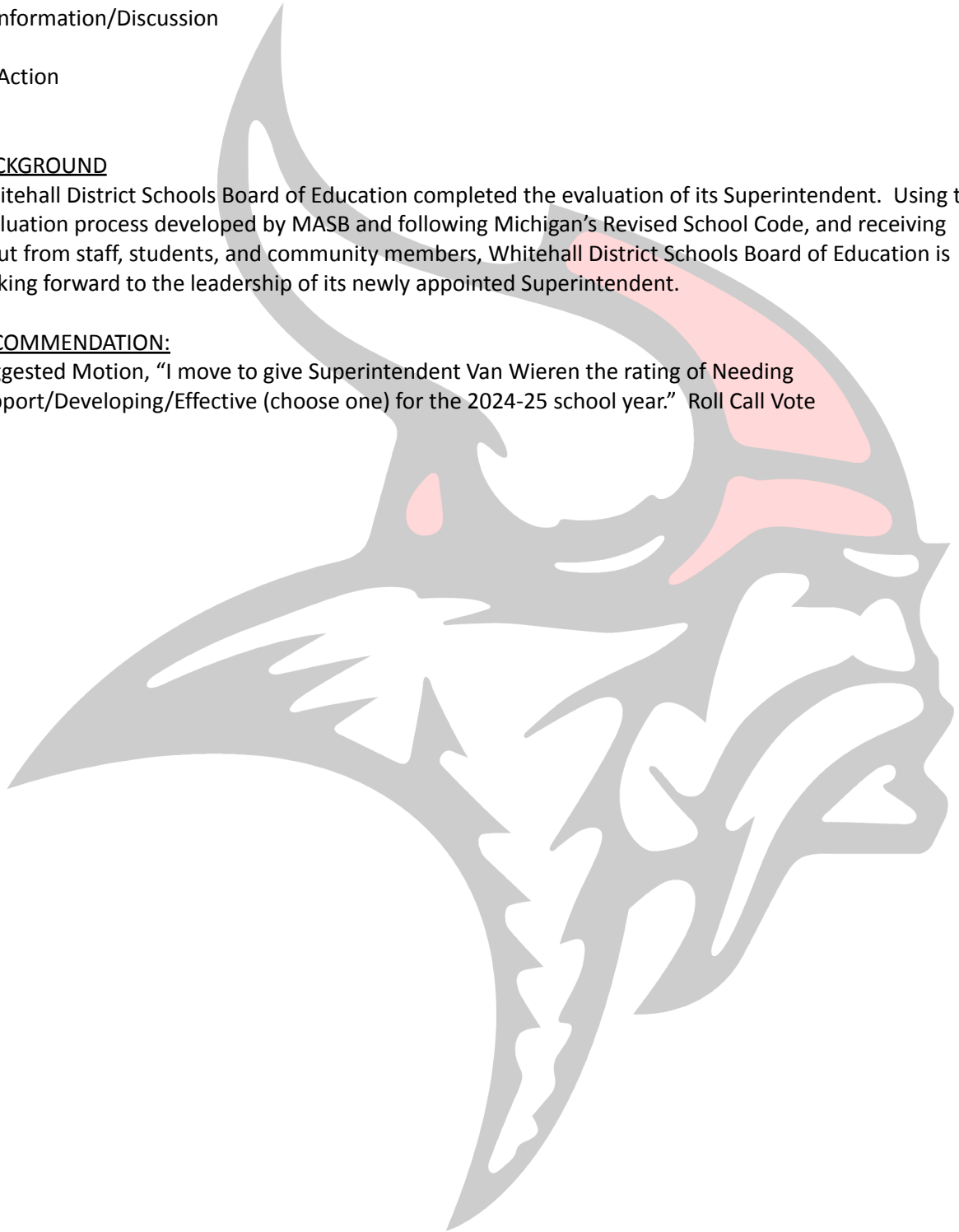
